Proposed procedure for electing disciplinary experts to UUCC committees

The UUCC has subcommittees that allow for the addition of disciplinary experts. the new Core oversight structure carved out space for "1-2 Disciplinary Experts" on four Core Curricular Subcommittees, appointed at the discretion of CAS and via CAS policies:

- Theological and Philosophical Foundations (Atria Larson)
- Eloquentia Perfecta 1: Written and Visual Communication (Nathaniel Rivers)
- Eloquentia Perfecta 2: Oral Communication and Creative Expression (Tim Huffman)
- Equity and Global Identities (Wynne Moskop)

Responsibilities: Disciplinary experts will serve on the UUCC subcommittees. They will attend the subcommittee meetings. The experts are not members of the UUCC and are not required to attend the UUCC meetings.

Proposed CAS policy/process for selecting disciplinary experts:

- Faculty Council solicits self-nominations to be sent to the FC Core Curriculum Committee. Self-nominations should be accompanied by a note of support from the chairperson of the self-nominating faculty member.
- Prior to reviewing self-nominations, the Core Curriculum Committee informs all CAS
 department chairs of the candidates under consideration. The committee will consider
 feedback from any chairs who perceive their departments to be impacted by any
 particular appointment.
- 3. The Core curriculum committee reviews the candidates and provides a recommendation to the Dean. When reviewing the candidates, attention will be given to
 - a. Support from their chair person as well as any other stakeholder chairs
 - b. Experience in curricular development
 - c. Experience with assessment.
- 4. Upon reviewing the committee recommendations, the Dean appoints the disciplinary experts.
