## Faculty Senate Meeting Minutes Tuesday September 19, 2023, 3:30 – 5:00 pm CDT

- 1. Call to Order
- 2. Roll Call: see below
- 3. Moment of Reflection. Kathleen Gillespie
- 4. Approval of May minutes- Minutes approved.
- 5. Key priorities as identified by Faculty Senators/FS Committees: FS President Chris Rollins noted that these priorities were identified by the FS over the last year and as a result each month the FS will be provided with updates on where things stand with regard to these issues. Given time constraints, these will begin to be addressed in October's FS meetings (note President's Research Council update below)
  - a. Longer term contracts for NTT

- 6. Responses to current questions/concerns. FS President Chris Rollins noted that this section of the agenda will be included in each month's FS meeting and will be a way to respond to issues, questions, concerns that the senators bring to the FS from their individual unit faculty and/or faculty councils/assemblies.
  - a. State Global Grad initiative (see slides): Provost Lewis highlighted the fiscal importance of diversifying the SLU student profile. There has been intentional marketing and promotion with the current focus on bringing in international students to tuition revenue generating master's programs, specifically those in the tech and business areas (though there has been some "halo" effect with other related programs also growing). The focused marketing and promotion has yielded excellent results and the University recognizes that with this comes the need to ensure that students who join the community are able to succeed while here. They have therefore been adding staff and support services for these international students to address within and outside the classroom needs.
  - b. Ombuds Position: (Lewis, Lisa Israel see slides) As of today, 09/19/23 there is now an ombudsperson available to North Campus and the law school (the ombuds position already exists at the medical school). This program is being run as a pilot and will include consultation with individuals, providing resources, facilitating conversations and meetings, and training and development (see slides for more specific information).
  - c. Libraries & Museums-plans and survey (Lewis/Jennifer Nutefall see slides) Dean Nutefall noted that an advisory committee is being formed with faculty representatives from all Schools and Colleges other than the School of Law that has its own Law library. The committee will be a platform for exchanging ideas and airing concerns. There will also be a university wide survey coming out in October. Rather than individual incentives, a dollar will be donated to the St Louis Area Food Bank, up to \$2500, for each completed survey.
  - d. Public Safety trainings scheduled (Mel Heikkinen). Mel Heikkinen discussed the Run, Hide, Fight training that is available upon request. They also offer self-defense classes and CPR/AED training. Senators asked about their concerns about both sexual assaults and vehicle thefts. In both instances, senators were assured that efforts are being made to increase patrols and provide individuals with the skills and tools to protect themselves. The community was encouraged to purchase steering wheel locks. It was also noted that SLU has background checks on its employees and is reexamining its use of contract workers. Housing that has been deemed unsafe has been removed from the lists provided to students regarding housing. Officers are working on positive engagement with students and student groups to encourage them to speak up if they feel uncomfortable.

- e. Employee climate survey discussion A university wide climate survey will be launced in October. It will be an in-house survey.

We've committed to addressing 16 different action items that have been assigned to 7 different work groups. Work plans have been submitted for a number of different areas including pre-award clinical trials, post award policy, development & training, and communications.
