I understand that if any side effects are experienced, it will be my responsibility to follow up with my physician at my expense. Mild reactions may include soreness, redness and/or swelling at the injection site, or arm stiffness. General reactions may include muscle pain, headache, fatigue or fever that can persist up to 1-2 days. Rare but severe reactions may include anaphylaxis or death and for age 6-35 months, febrile convulsions. • I hereby release and hold harmless Visiting Nurse Association of Greater St. Louis, its staff, agents, successors, divisions, affiliates, subsidiaries, officers, directors, contractors, volunteers and employees, from any and all liabilities or claims whether known or unknown arising out of, or in connection with, or in any way related to the administration of the vaccine(s) listed above.
