GENERAL INFORMATION

STUDENT RESPONSIBILITIES

As an 1818 student, it is your responsibility to:

- Inform your parent/guardian of your participation in the 1818 Program.
- Understand the policies for dropping and withdrawing from 1818 coursework (pg. 4).
- Pay course tuition by the given deadline (pg. 2).
- Register independently and keep track of your login information.
- Understand the credit transfer process (pg. 5).

STUDENT PRIVACY

FERPA — or the Family Educational Rights and Privacy Act — is a federal law that protects the privacy of student educational records. It should be noted that at the university level, the rights afforded by FERPA belong, in general, to the student rather than the parent. Saint Louis University can only share certain student information with parents if the student has provided consent on their application form, and the parent's contact information is listed.

COST, BILLING & SCHOLARSHIPS

COST & BILLING

The tuition rate for 1818 courses is \$85 per credit hour. Most courses are 3 credit hours, totaling \$255. Exceptions include lab courses (1 credit hour) and select math courses (4 credit hours).

Your current balance owed can be found on your emailed billing statement that is sent after the registration period each semester. Families should not attempt to pay until they have received a bill.

FALL/YEARLONG DEADLINE: DECEMBER 1
SPRING DEADLINE: MAY 1

LATE & NONPAYMENT

All students with an outstanding balance on their account beyond the payment deadline will have the a registration hold placed on their account.

A registration hold prevents students from registering for future Saint Louis University coursework, both 1818 and as a full-time undergraduate.

There are no late fees for late payment. Once payment has been received and processed by SLU, the registration hold will be lifted from the account.

Students will not be unenrolled for nonpayment. Students that fail to withdraw by the provided deadline will still be responsible for paying for coursework and will receive their assigned grade on their SLU transcript, even if it is a failing one.

PAYMENT

Payment can be submitted online or via check in custom installments. SLU does not accept payment over the phone.

To complete an online payment, you will need the student's banner ID number and tuition amount. If you do not receive this information within a month after the registration period ends (via email or mail), please contact 1818@slu.edu.

SLU accepts the following online payment methods:

- Payment via Bank Account
- Credit Card (payments made by credit card incur a nonrefundable 2.85% fee)

Pay by Mail

MySLU



Every SLU student, including those in the 1818 Program, has a MySLU account that provides access to their class schedule, grades, and other campus-wide services. Once a student is enrolled in the 1818 Program, they will receive an email with login information for their account.

FIRST TIME 1818 STUDENTS

After being enrolled into the 1818 Program, you will be sent an email containing the following information to set up your MySLU account:

- Your SLUNet ID
- A temporary password

RETURNING 1818 STUDENTS

You will continue to use the same SLUNet ID issued to you when you were first admitted to the 1818 Program. If you forgot, or do not know your SLUNet ID or password, contact 314-977-4000.



GRADING, DROPS & WITHDRAWALS



GRADING

1818 students are held to the same academic standards of grading as undergraduate students taking the same course at Saint Louis University. Upon completion of the course, the high school 1818 instructor will post a letter grade to your SLU transcript.

In most cases, this will be the same letter grade you received in the high school course. In certain circumstances when the SLU grading policy and the high school grading scale differ, you may receive a grade that is different from your high school grade. Talk to your 1818 instructor for further details.



Each college or university has their own policies on accepting grades. It is the student's responsibility to determine how 1818 grades will transfer to other higher education institutions.

DROPS

To **drop** a 1818 course, or completely remove it from your Saint Louis University transcript, students will need to log into their DualEnroll account and 'abandon' any courses they no longer wish to take. Students will not owe a balance for any dropped courses. Please refer to page 1 for all drop deadlines.

WITHDRAWALS

To **withdraw** from an 1818 course, or unenroll and receive a status of "W" instead of a grade, please email 1818@slu.edu with your name and courses you'd like to withdraw from.

Withdrawing from a course can have a neutral or negative impact on your college admissions depending on the university you apply to. Receiving a "W" is always better than receiving a failing grade. Students who withdraw are responsible for paying for their coursework. Please refer to page 1 for all withdraw deadlines.



CREDIT TRANSFER

TRANSFERRING CREDITS

Acceptance of 1818 credit is determined by each college or university. It is the student's responsibility to research how 1818 credit transfers to the degree programs and institutions they are interested in.

QUESTIONS TO ASK



Students are encouraged to ask colleges and universities the following questions:

- 1 Does your institution accept dual enrollment credit?
- 2 How would SLU dual credit apply to the degree program I am interested in?
- 3 Will I be considered a freshman regardless of the number of credits I transfer? (Make sure you would still be eligible for all freshman scholarships)
- 4 Would the credits or GPA I bring count against the overall length and amount of any scholarship I might receive?

ORDERING TRANSCRIPTS

Transcripts can be ordered once the student's bill has been paid in full and instructors have submitted grades to SLU. If possible, traditional seniors should wait until **June 2nd** or later to send transcripts. If a grade is needed sooner, please contact your 1818 instructor(s).

Transcript Request

E-transcripts can be ordered online with the student's SLU Banner ID number or Social Security number. E-transcripts cost \$4 to send and are typically received within 24-48 hours of ordering.
