## **TEACHING**

I teach courses in the history of Western social, political and moral philosophy, and on the Frankfurt School. I also teach a course on social ontology and the analysis of structural power, called “Capitalism, Patriarchy and Racism,” as well as an upper-level seminar on *Capital, Vol. 1*. I regularly teach Plato and Aristotle in some depth, and have also taught an intensive course on Kant’s *1<sup>st</sup> Critique*. Various of my courses are cross-listed (philosophy/political theory). Since 2018 I have designed and taught three new courses, which I plan to continue to offer: “Theories of the Capitalist State,” “Fascism” and “Radical Political Thought.”
