#### <u>Amazon</u>

As mentioned at December's Business Manager meeting, Saint Louis University has created a centralized Amazon Business account that is now accessible in Billiken Buy. Our goal is to simplify the purchasing process so you can take advantage of the wide selection and competitive prices of the Amazon Business marketplace, leveraging a competitively awarded US Communities purchasing cooperative contract.

Through this central Amazon Business account you will have immediate access to:

- Free Shipping on orders over \$25
- Pricing and quantity discounts on a growing selection of products
- Enhanced search and browse functionality
- Access to a specialized Customer Service team Amazon Business PunchOut Customer Service 888-281-3847.

In addition to the benefits above, the business account offers tax exemption and pay by invoice thus reducing Pcard reconciliation. For these reasons, we strongly encourage shopping in Amazon through Billiken Buy.

To begin purchasing, click on the Amazon Business option in Billiken Buy. The first time you try to shop on Amazon Business in Billiken Buy you will be prompted to create an Amazon Business account using your SLU email address. Once you have completed your setup you can immediately start shopping on Amazon Business.


