Updated Golf Cart Rules and Regulations

All University owned or leased powered cart vehicles need to be stored in a secure location, preferably in a parking garage or other secure area. All vehicles must be equipped with an anti-theft locking mechanism of some kind when not in use. You may purchase one online, at the time of purchase, or you can reach out to Facilities Services to have your steering column drilled for a lock.
