• A summer financial aid application is how you notify our office that you wish to have consideration for a financial aid package for the 2021 summer term.

## What aid might be included in a summer financial aid package?

- SLU undergraduate scholarships are **not applied** during summer terms.
- Students eligible for Federal Direct Loan and/or Pell Grant funds will be packaged with remaining eligibility. Students who have utilized the Direct Loan eligibility for the 2020-2021 academic year may be eligible to borrow a Parent PLUS loan, private student loan **OR** Graduate PLUS loan (for Graduate/Professional Students). # FAQ's For Summer 2021 Financial Aid

# Who is Eligible?

The majority of summer aid programs will require enrollment of at least half-time in a degree granting or eligible certificate program at Saint Louis University (SLU). Please see the table listed below.

\* If you do **not** plan to enroll in summer school, but you will be enrolled at least half-time in a degree granting or eligible certificate program at SLU during the Fall 2021 semester, you may be eligible to receive Federal Work Study.

## What is Available?

Most applicants are able to borrow to cover certified summer school costs through various loan programs. There is limited funding in certain programs, such as Federal Work Study.

# **Application Requirements**

- Submit 2021 Summer Financial Aid Application
- File (or already filed) the 2020-2021 Free Application for Federal Student Aid (FAFSA) no later than June 30, 2021.
- \*Students not enrolled for summer classes may be eligible for Federal Work Study **ONLY**; these applicants must file the 2021-2022 FAFSA and have met all mandatory requirements.
- Summer aid decisions will be communicated to students as processed and continue on a rolling basis as applicants are received.
- Completing this form does NOT guarantee financial aid will cover Summer 2021 expenses.
