HEERF Student Funds Quarterly Reporting Summary October 4, 2021

As signed and agreed to, Saint Louis University was awarded additional funding from the ARP of \$7,488,955 to assist students with emergency needs.

For the Fall 2021 a total of \$5,684,000 has been disbursed to students.

The University determined awards in the same manner as previous CARES and CRRSAA funding. Grants were awarded to Pell Grant recipients and to students from an application process. Pell Grant recipients were automatically notified of awards. Other communications to the campus community included an email to all students, notice on the website page for Emergency Funding, and referrals.

From July 1, 2021 to September 30, 2021 (Q3) a total of \$7,212,295 was paid in 3569 awards to 2740 students.

Additional awards will be made by November 30, 2021 and January 30, 2022.

Since January 18,2021 to September 30, 2021, a total of \$8,915,695 has been awarded to students.

During Q3 (July 1, 2021 through September 30, 2021) a total of \$7,212,295 was awarded to students.

Based on the University's total enrollment, an estimated 12,000 were eligible to apply for grant consideration under the American Rescue Plan.

(5) The total number of students who have received an Emergency Financial Aid Grant to students under the CRRSAA and ARP (a)(1) and (a)(4) programs.

The total number of student awards from CRRSAA and ARP is 6170 (HEERF II and ARP). The unduplicated number is 3,740.

During Q3 (July 1, 2021 through September 30, 2021) a total of 3569 awards with 2740 students receiving funds.

(6) The method(s) used by the institution to determine which students receive Emergency Financial Aid Grants and how much they would receive under the CRRSAA and ARP (a)(1) and (a)(4) programs.

### Summer 2021 Awarding:

Saint Louis University awarded 629 awards to 529 students HEERF and ARP funds. The methods of awarding included a block grant to Pell recipients and an application for students to identify additional specific impact and needs.

There were 347 block grants awarded and 282 awards from the application.

### Fall 2021 Awarding:

Saint Louis University awarded 2546 students HEERF and ARP funds. The methods of awarding included a block grant to ensure the neediest students received monies quickly and an application for students to identify additional specific impact and needs.

Phase 1 consisted of block grants awarded to 1516 Pell Grant recipients enrolled for Fall 2021. These students received \$2000 each..

Phase 2 awarding included a COVID-19 Relief Request Application. The intention of the application was for students to request for a specific purpose and provide some details of their current situation allowing the application to be used for multiple emergency sources, not explicitly federal funds.

Funds identified for awarding utilizing the COVID-19 Relief Request Application included HEERF/ARP monies as well as some institutional funds.

The distribution of funding occurred for Summer 2021 from May 5 to July 30, 2021 and Fall 2021 for applications received by census, September 7, 2021.
