- Submit <u>a copy of documentation of foster care status</u> if you were in foster care at any time since you turned age 13, even if you are no longer in foster care today.

EMANCIPATED MINOR: Submit a copy of an approved petition for emancipation, court orders, or other similar legal papers documenting emancipation as a minor. The documentation must confirm the student was emancipated prior to age 18.
Note: Emancipation due to a parent's divorce or child support termination <u>does not</u> meet the requirement as emancipated minor.

LEGAL GUARDIANSHIP: Submit documentation of legal guardianship immediately before the age of 18. This could include a copy of the approved petition for guardianship, court order, or other similar legal papers.

NOTE: This does not include guardianship to a biological parent resulting from a divorce or separation agreement.

**HOMELESS OR UNACCOMPANIED YOUTH:** Submit supporting documentation (from a recognized third party such as homeless shelter, school district, Trio or Gear Up) of being an unaccompanied youth who was homeless or self-supporting and at risk of being homeless at any time on or after July 1, 2022.

## ACTIVE-DUTY MILITARY STATUS:

- If you are currently on active duty with the U.S. Armed Services, submit a letter from your unit commander documenting your active duty status.
- If you are a member of the National Guard or Reserves, and currently on federal active duty for other than training purposes, submit a letter from your unit commander documenting your active-duty status.

**NOTE:** If you are unable to document your independent status based on the above categories, then you are considered dependent for financial aid purposes. Please login to your FAFSA at <u>studentaid.gov</u> and answer "NO" to question 42-54. You must also provide parental income and asset information as well as a parent signature (your parent can sign electronically using his/her own FSA ID). If you face extenuating circumstances preventing you from obtaining parental information for the FAFSA, please contact your Student Financial Services Counselor.
