HEERF Student Funds Quarterly Reporting Summary March 31, 2023

Saint Louis University received over \$12,636,335 in COVID related funding (COVID, HEERF, and ARP). These proceeds were received from April 2020 to May 2021. Disbursements to students occurred from April 2020 until December 2022. These funds were allocated to assist with emergency needs or losses due to impact of the pandemic.

Saint Louis University has spent all funds or returned any remaining. No further activity is anticipated on these records.

Specifically during the period January 1, 2023 to March 31, 2023, no additional funds were disbursed, however, any undeliverable checks were voided and funds returned to ARP grant.

Based on the University's total enrollment, an estimated 12,000 were eligible to apply for grant consideration under the American Rescue Plan.

During Q4 (October 1, 2022 to December 31, 2022) a total of \$47,970.00 was disbursed to 78 students. All students were Pell recipients.

(6) The method(s) used by the institution to determine which students receive Emergency Financial Aid Grants and how much they would receive under the CRRSAA and ARP (a)(1) and (a)(4) programs.

Fall 2022 Awarding:

Saint Louis University awarded 78 students \$615. The students were Pell Grant recipients in fall term and all demonstrated additional need.

Through the American Recovery Plan — part of the federal stimulus allocations prompted by the COVID-19 pandemic — SLU has emergency funding available to eligible students in 2022-2023 academic year, allowing us to further assist students who demonstrate exceptional financial need.

Grants have been automatically distributed and refunded to those students who are enrolled in the Winter 2022 term and receive a federal Pell grant. Because these grants are automatic, there is no further action required by those students or their families.
