WHAT is the '2011 Compliance Update' mandatory session?

- A session which will be offered several times each month in a variety of locations that covers general compliance initiatives, prevention of fraud, waste and abuse and HIPAA privacy and security updates
- The only mandatory course/session
- All other courses/sessions offered by the Academy are elective unless required by your clinical department chairman or for remediation following an incident or issue
