Student Learning Outcomes

On successful completion of the course the student will have the following abilities.

1. To solve integrals using a variety of methods.
2. To apply integration to evaluate arc lengths, areas and volumes.
3. To evaluate improper integrals.
4. To study convergence (and divergence) of sequences and series.
5. To write down the Taylor series of a given function.
6. To work with power series.
7. To solve basic differential equations using the method of separation of variables.
