

NURS 3330 - Pharmacotherapeutics for Nursing Care Spring 2018

Course Description:

This course develops the student's knowledge of the nurse's role and responsibilities in drug therapy, based on the application of concepts from nursing and pharmacology. Legal, ethical, and life span considerations will be presented as they apply to the nurse's role in drug therapy. The student will have the opportunity to study groups of drugs using a structured, systematic approach that includes general principles of drug activity, major actions, therapeutic effects, and adverse reactions. The student will learn to apply the nursing process to the care of the patient receiving drugs in a variety of clinical situations.

Course Objectives:

At the end of this course the student will be able to:

- 1. Identify the scope of pharmacology in nursing practice.
- 2. Classify drugs into major groups according to physiologic action and primary clinical use.
- 3. Understand the basic pharmacology of drugs and their clinical applications to practice safe and effective nursing care
- 4. Discuss principles of pharmaceutics, pharmacokinetics, and pharmacodynamics as they apply to various drugs and/or drug classifications.
- 5. Describe the basis of nursing assessment and diagnosis in the care of clients receiving various categories of drugs.
- 6. Identify nursing interventions which maximize therapeutic effectiveness and minimize adverse reactions associated with drug therapy.
- 7. Identify variations in drug activity, use, and nursing interventions for drug therapy across the life span.
- 8. Discuss ethical and legal principles applicable to nursing care for patients receiving medications.

The course textbook has an accompanying on-line student support site. Students are required to register on-line and use the student resources for this course. Enroll on-line using the following steps:

- 2. Click on Evolve Resources
- 3. Type in "Lehne" and select the 8th Edition
- 4. Seclect "Working on your Own" and then "Register for this now" (an orange tab)
- 5. Next screen, select "Redeem/Checkout" (another orange tab)
- 6. Create a new profile, filling in the required fields. Note: choose Spain for country and please supply your SLU email address.
- 7. Click the "User Agreement"
- 8. You are now enrolled. You will receive an email, confirming your enrolment. Please print this out and put it in your folder.

Once you have enrolled, you can access NCLEX exam-type questions. Once the course comments, you will be given a list of chapters that you must complete on-line.

To access the questions, use the following steps:

- 1. In evolve, click on the book icon and it brings up all the chapters.
- 2. Click on the chapter you want, then click on the folder "Student Resources"
- 3. Click on "Prepare for Exams"
- 4. Do the NCLEX quiz. You will be given feedback on your answers.
- 5. Print out the quiz and keep it in a dedicated folder.

You will also be given homework assignments throughout the course – your answers should also be stored in the folder. Folders will be assessed and form part of your final grade.

Extensive use of the SLU Global Learning System will be employed. All lectures will be posted there and it should be checked daily for announcements.

Attendance Policy:

Attendance is required at all lectures. Absence from class must be accounted for. More than <u>four</u> unaccountable absences will result in a drop in the final grade. Continual lateness to class is disruptive and not acceptable.

Course Requirements and Grading Rationale/System:

All cell phones must be turned off or to vibrate during class times.

<u>Testing</u> – There are three exams for this course: two mid-terms and a final. The exams are NOT cumulative, thus the first mid-term will examine the material covered up to this exam. The second mid-term will examine the material covered *after* the first mid-term and the final exam will examine the material covered *after* the second mid-term.

However, there is also a comprehensive final exam that examines **all** of the course material. This exam is <u>obligatory</u> for students who fail or miss either mid-term exam. It is voluntary for any students who, having done their mid-terms, would like to try and improve their grade (but a poor result may obviously reduce the grade).

Scheduled test dates will be strictly adhered to. Students who are ill and present a valid health care practitioner's statement attesting to that illness, may reschedule the test without penalty. Make-up tests must be scheduled at the earliest possible opportunity. Travel is NOT a reason to reschedule a test.

There will also be two **Quizzes**, taken in class, just before the two mid-terms. The aim of these quizzes is to encourage study and revision for the mid-terms. The score on these quizzes does not count towards the final grade.
