A new didactic curriculum is being implemented. There will be six pediatric dentistry courses of 6 to 10 weeks each that will be delivered over the two year curriculum. The content of the courses are based on the American Board of Pediatric Dentistry core curriculum. At the conclusion of each course a final exam will be given. We are in the process of hiring a new dental assistant to increase the amount of restorative experiences the residents get in the dental clinic. If no changes are being made, please explain why. 7. Closing the Loop: Review of Previous Assessment Findings and Changes A. What is at least one change your program has implemented in recent years as a result of assessment data? The increase in OR experiences for the residents.

B. How has this change/have these changes been assessed?

The impact of the change was assessed by tracking the number of OR cases completed by each resident.

C. What were the findings of the assessment?

The assessment showed that each residents is now getting over 100 operating room experiences during the two year program. Only 20 cases are required by accreditation standards.

D. How do you plan to (continue to) use this information moving forward?

We continue to monitor the number of cases performed by each resident to ensure adequate distribution among the residents and ensure the high number of these experiences continue.
