Students in this cohort were below the benchmark outcome on the ATI RN Comprehensive Predictor Exam items for: BSN Essentials: Information management and applications of patient care technology. This items was an outcome for SLO #13.

Students in this cohort were below the benchmark outcome on the ATI RN Comprehensive Predictor Exam items for:BSN Essentials: Professionalism and Professional Values. This item was an outcome for SLO #9

We were below the benchmark on one outcome for SLO #9 Applying the professional code of ethics and professional standards to clinical practice. We are in the process of introducing a new course called Developing Professional Nursing Identity and Communication Competencies which we hope to introduce in summer 2024. We will also be revising the assignments in NURS 2520 to include weekly assessments of professionalism outcomes as part of the grade for that course.

We were below the benchmark on one outcome for SLO # 13 Utilize appropriate information and healthcare technologies to enhance the delivery of client care. Nursing informatics, which addresses the utilization oof appropriate information and healthcare technologies to enhance the delivers of client care has been an ongoing area of concern. We discussed this topic prior to the beginning of our fall term 2022 and will continue to strategies ways to enhance students understanding of the content.

7. Closing the Loop: Review of <u>Previous</u> Assessment Findings and Changes

A. What is at least one change your program has implemented in recent years as a result of assessment data?
 Our students struggle most in the summer term. In summer 2022, we re-arranged the course sequencing to offer all six summer courses over the entire 11-week summer term.

B. How has this change/have these changes been assessed?

These changes were assessed formally by progression rates and informally by faculty and student satisfaction comments.

C. What were the findings of the assessment?

This change was not well received by the student or the faculty and the program progression of 25% of the cohort was negatively affected.

D. How do you plan to (continue to) use this information moving forward?

Summer 2023 we pivoted back to the prior course sequencing in which the course load was divided into two sections: the first half of the summer concentrated on courses with more hands-on or group learning and the

second half concentrated on more theory didactic learning. We are in the process of adopting the Common Core requirements.

We are also revising our curriculum to adopt the new American Academy of College of Nursing (AACN) Essentials. This information will inform decision moving forward with these changes.

Social Media Campaign Project

DESCRIPTION: This project integrates the core functions of public health and health promotion. The project focuses on identifying a health promotion topic geared towards a specific population, assessing the quantitative and qualitative date on the health promotion topic, developing a social media campaign utilizing a health promotion/health behavior change theory or model to address the health promotion topic, and evaluating the impact of the social media campaign.

PURPOSE: The purpose of this project is to effectively utilize communication methods and social media to educate a specific population on a health promotion topic appropriate for them.

OBJECTIVES: At the end of the activity, the learner will:

- 1. Identify health needs of the selected population based on a literature review.
- 2. Utilize web-based data to identify current resources available for the selected population.
- 3. Utilize the CDC's Social Media Toolkit to help design a social media campaign utilizing a theoretical framework via a selected social media platform to promote the topic.
- 4. Develop a social media campaign addressing a health promotion topic appropriate for a selected population.
- 5. Develop three measurable objectives.
- 6. Identify three specific media tactics for the campaign, but focus on one for the campaign.
- 7. Work collaboratively in the clinical group.
- 8. Evaluate the effectiveness of the campaign.
- 9. Present findings with members of the clinical group to class.

Examples of health promotion topics:

- Seatbelt use
- Vaccinations (infant, school-age, adolescent, adult, older adult)
- Self-breast exams/Testicular self-exams
- Fruit and vegetable consumption
- Flu vaccine
- Screenings for a health concern (ex mammograms)
- Drug/Alcohol use
- Texting while driving/distracted driving

- Transtheoretical Model
- Theory of Reasoned Action
- Theory of Planned Behavior
