- 3. David Kaplan -Collaborative Inquiry
 - Need to build capacity for new courses
 - Currently accepting provisional course to be taught for a semester or two
 - Changes to make application process easier
 - o Additional guidance to help faculty create courses
 - What are the qualifications for a Collaborative Inquiry course
 - o Prerequisite: Student must have taken at least 60 hrs
 - o Courses must be centered around a multidisciplinary subject area
 - Course is a Junior-Senior level course that requires students to work in groups to solve a question.
- 4. Liz Burke- Grade Appeal Process (Committee approves with additional changes)
 - Changes to the process—Align dates of appeal initiation and instructor grade record keeping with University policy; remove "capricious"; revise Step 1 in procedure to include protocol if instructor is no longer employed at the University
