OSHA 510 OCCUPATIONAL SAFETY AND HEALTH STANDARDS FOR CONSTRUCTION

OSHA 511, OCCUPATIONAL SAFETY AND HEALTH STANDARDS FOR GENERAL INDUSTRY

These courses introduce private sector personnel to OSHA policies, procedures and standards with an orientation toward compliance. These courses are recommended for anyone who will have responsibility for oversight of workplace safety and health; they are also prerequisites for the OSHA Outreach trainer courses, OSHA 500 and OSHA 501.

#500 TRAINER COURSE IN OCCUPATIONAL SAFETY AND HEALTH STANDARDS FOR THE CONSTRUCTION INDUSTRY

#501 TRAINER COURSE IN OCCUPATIONAL SAFETY AND HEALTH STANDARDS FOR GENERAL INDUSTRY

These courses are for **those interested in teaching the 10-hour and 30-hour safety and health outreach course.** They build on the OSHA 510 and OSHA 511 courses aligning with the required topics for outreach courses. Emphasis is placed on the concepts of adult learning, instructional design and practice. After successful completion of this course you will be authorized by OSHA to conduct the appropriate 10 and 30-hour courses and issue completion cards to students. OSHA 500 focuses on Construction while OSHA 501 focuses on General Industry.

NOTE: Students must have completed applicable prerequisites (OSHA 510 or 511) and document five (5) years of industry-specific, safety-related experience. Pre-application and approval is required before registration. Students seeking to become OSHA Authorized Outreach Trainers must successfully pass a written exam and oral presentation.

COURSE INFO

CEET provides the OSHA General Industry and Construction Standards courses, Trainer courses and Update courses every two months.

#502 Trainer Update Course in Occupational Safety and Health Standards for the Construction Industry

#503 Trainer Update Course in Occupational Safety and Health Standards for General Industry

Trainers that have completed OSHA 500 or OSHA 501 must maintain their certification by taking OSHA 502 (Construction) or OSHA 503 (General Industry) refresher courses every four years.

OSHA 10 AND 30 HOUR OUTREACH COURSES FOR CONSTRUCTION AND GENERAL INDUSTRY

The OSHA 10 Hour courses provide an introduction to occupational safety and health **recommended for general workers**. Course topics focus on hazard recognition and include an introduction to OSHA, hazard communication, personal protective equipment, means of egress and other topics.

The OSHA 30 Hour courses offer an expanded view of hazards in the workplace. These courses are **recommended for supervisors or others who need a more in-depth understanding of workplace hazards**. Emphasis is placed on topics related to the most frequently cited OSHA violations. Individuals seeking to learn about OSHA standards or compliance should take the OSHA 510 or OSHA 511 courses.

Note: These courses are not required by OSHA and completion of these courses does not meet OSHA's compliance obligations for training workers. However, some governmental agencies, labor organizations and employers require these courses before workers are allowed on the job site.

SINGLE TOPIC OSHA COURSES – ½ DAY TO 5 DAYS IN LENGTH
