In August 2024, the SLU/YouGov Poll asked 900 likely Missouri voters:

"Approximately what percentage of the costs of the construction of professional sports facilities (e.g., stadiums and arenas) should the following be responsible for:"

- Owners of the Teams?
- The Missouri State Government?
- Local Governments (e.g., Cities and Counties)?

Respondents allocated percentages to total 100%. The following pages provide survey results for the full sample and demographic subgroups, along with details about the survey. Results from the full survey are available at https://www.slu.edu/poll.

Key Findings: How much should the government and owners pay?

At least 50% Missouri voters believe...

- ...the owners of teams should be responsible for at least 70% of the costs.
- ...the Missouri state government should be responsible for less than 13% of the costs.
- ...local governments should be responsible for less than 15% of the costs.

Subgroup Findings

Republican, Democratic, and Independent Voters

- 68% or more think the owners of teams should be responsible for at least 50% of the costs.
- 9% or fewer think the state government should be responsible for at least 50% of the costs.
- 8% or fewer think local governments should be responsible for at least 50% of the costs.

Above percentages apply to each Republican. Democratic, and Independent voters

Royals, Chiefs, and Cardinals Fans

- 71% or more think the owners of teams should be responsible for at least 50% of the costs.
- 9% or fewer think the state government should be responsible for at least 50% of the costs.
- 7% or fewer think local governments should be responsible for at least 50% of the costs.

Methodology and Weighting

YouGov interviewed 1154 Missouri (MO) registered voters, with the goal of screening for and surveying Missouri likely voters. The Missouri registered voters were then matched down to a sample of 988, yielding a target subsample of 900 likely voters including 450 from each treatment group. The respondents were matched to a sampling frame on gender, age, race, education and treatment group. The sampling frame is a politically representative "modeled frame" of US adults, based upon the American Community Survey (ACS) public use microdata file, public voter file records, the 2020 Current Population Survey (CPS) Voting and Registration supplements, the 2020 National Election Pool (NEP) exit poll, and the 2020 CES surveys, including demographics and 2020 presidential vote.

The matched cases were weighted to the sampling frame using propensity scores. The matched cases and the frame were combined and a logistic regression was estimated for inclusion in the frame. The propensity score function included age, gender, race/ethnicity and education. The propensity scores were grouped into deciles of the estimated propensity score in the frame and post-stratified according to these deciles.

The weights were then post-stratified on 2020 presidential vote choice as well as a four-way stratification of gender, age (4-categories), race (3-categories), and education (4-categories). The weighted dataset of registered MO voters was then subsetted on likely MO voters, and the weights were trimmed and recentered around 1, to produce the final weights for likely Missouri voters.

Coding Decisions

The first two rows of the tables on the previous pages report the mean (average) response for each group and the median (50th percentile) response.

Subsequent rows indicate the percentage of voters who responded to a question with a percentage above a certain level. For example, the row "Pct. Voters Stating... at least 25% of costs" present the percentages of voters who indicated that owners, the state government, or local governments should pay at least 25% of the costs. To create this variable, the SLU/YouGov Poll Team coded respondents' responses as 1 if they stated a percentage of 25 percent or higher (e.g., 25%, 45%, 75%), and 0 otherwise. Coding is similar for "Pct. Voters Stating at least 50% of the costs" and "Pct. Voters Stating at least 75% of the costs."
